### Que. What is PNB PALAASH GREEN DEPOSIT?

**Ans**. PNB PALAASH Green Deposit is an interest-bearing term deposit, received by the bank for a fixed period and the proceeds of which are earmarked for being allocated towards green finance. These green deposits are to be utilized for financing specified Green Activities only.

### Que. Whether Joint account can be opened in PNB PALAASH GREEN DEPOSIT?

Ans. Yes, joint account can be opened under the scheme.

# Que. Whether Nomination Facility is allowed under PNB PALAASH GREEN DEPOSIT?

Ans. Yes, nomination facility is allowed under PNB PALAASH GREEN DEPOSIT.

# Que. Whether there are any restrictions like age, income, etc. criteria for opening PNB PALAASH GREEN DEPOSIT by banks for individuals?

**Ans.** PNB PALAASH GREEN DEPOSIT can be opened by Individuals /Proprietorship firms / Partnership firms / Private and Public Limited Companies / HUFs / Specified Associates / Societies / Trusts, Departments of Authority created by Government (Central or State), Limited Liability Partnership, etc. with minimum deposit of Rs.5000.00 and thereafter in multiples of Re.1/- with maximum deposit amount less than Rs.10.00 Cr. There is no such age restriction.

# Que. What is the period of deposit and interest option under PNB PALAASH GREEN DEPOSIT?

**Ans.** There are two options for period of deposit- 1204 days and 1895 days. The interest on PNB PALAASH GREEN DEPOSIT is payable to customer either on maturity option or on income option.
